Everycontractor appoints Ben Bassi, Co-Founder of Lycos to Board of Directors and Paul Chevrier as Chief Technology Officer

Las Vegas, NV. – April 20, 2001 - Everycontractor, Inc. a leading one- stop destination developed for the building and construction industry, today announced the appointments of Internet industry veteran Ben Bassi to its Board of Directors as an active participant and Paul Chevrier as Chief Technology Officer (CTO), effective immediately. The two Boston-based executives will bring 40 years of experience, knowledge and expertise of the Internet and Construction industry to Everycontractor. Mr. Bassi is a seasoned pioneer with a proven track record in high technology with more than 20 years experience in bringing companies from the start-up phase through successful acquisitions and IPOs. He will advise and assist in the growth of the company including in the areas of strategic planning, acquisitions/mergers and expansion capital. Mr. Chevrier brings to the Company a rare combination of key elements that is essential for the CTO position....his expert knowledge of information technology along with a successful background in construction management, engineering and business administration. Everycontractor provides the basic building blocks where customers can now obtain an updateable customized website and belong to a community of over 350 city specific informational city pages.

"We are extremely excited to have individuals of the calibre of Ben and Paul to be part this company, to share its vision and to help us achieve its next level of growth," said David Johnson, Founder and Chairman. " Ben Bassi's distinguished record as a leader and innovator in the Internet industry combined with his stellar background and impressive resume has been proven by his results achieved at his last five companies – with two companies going public and three being successfully acquired. He help build one of the most popular Internet sites that has developed into what is today...a major global Internet network operating in 41 countries in 19 languages, reaching 94 million uniquely monthly visitors worldwide and is also the third largest Internet access provider in the World. His input and industry relationships will be a tremendous asset to the company. Paul Chevrier is a strong leader and team player with an impressive track record and embodies all the characteristics that make him the perfect choice to be Everycontractor's CTO. As we evolve and innovate, his knowledge, vision and experience in working on some biggest construction projects in U.S history will help us create, guide and convert Everycontractor's product vision into reality."

Mr. Bassi was a founding member of Lycos' (NASDAQ: TRLY) and its initial Vice President of Business Development, who helped evolve the company from a college research project to a public entity which became one of the top 5 Internet sites in the World and also the fastest company to go public in the history of the NASDAQ. He was responsible for creating the first portal traffic agreements and licensing their technology to companies like Time Warner, Viacom, GTE and Microsoft as well as spearheading the joint venture with Bertelsman in Europe.

At Firefly Network, Mr. Bassi as COO, led efforts with the FTC, Microsoft and Netscape to develop Internet privacy standards, which resulted in the sale of the company to Microsoft (NASDAQ: MSFT). Firefly's "Passport" was subsequently released as the universal registration and personalization profiling mechanism for MSN's network. Bassi then went on to found CommonPlaces, a Cambridge-based B2B Internet Infrastructure company which he created the ability to reach over 12 M young adults both online and offline with 100% sales growth. He obtained funding totaling \$75 M and created liquidity for initial investors within 18 months before selling last year to Youthstream Media Networks where he was President of the 300 plus employee public company during the transition. Youthstream became the largest college media company with Internet properties resulting in almost 4 M members and 100 M page views per month.

Prior to Lycos, Bassi was Vice President of Sales at Object Design (NASDAQ: EXLN), which was ranked number one on the "1994 INC 500" list with a record 23,376% sales growth over five years. He closed and

negotiated a \$27M deal with IBM and received the 1993 ODI MVP Award. Customers included AT&T, BellSouth, Chemical Bank, Fidelity, Lehman Bros., Goodyear, MCI, NYSE and UPS. Bassi also ran strategic sales for McDonnell Douglas' billion-dollar computer company and regional sales for EDS.

Every contractor's principal technology visionary, Paul Chevrier has been involved in creating complex management systems for intricate construction projects as well as some of the most advanced computer database systems and network communication technologies to help engineering and construction contractors get their jobs done, on time and in budget. Since 1992, Mr. Chevrier founded TCSA, an information technology consultancy firm specializing in work group applications, systems and network integration and multi-tier database developments. Chevrier has consulted and implemented custom systems for many of the nation's largest construction, utility and environmental projects.

From 1992 to 1995, TCSA was a key consulting provider of custom information system solutions for the Directorate and Operations staff of the U.S Department of Energy's URA Super-conducting Super-Collider Laboratory, a proposed 54 mile circular high energy particle accelerator to do the World's most major research into the smallest particles of matter and the physics that control their makeup. Another major project in the early 90's was the \$6 billion Boston Harbor Cleanup Project where Chevrier and his team designed and created the construction management information systems and implemented the first large-scale environmental construction project client server RDMS in PC Windows using both LAN and WAN PC and VAX networking. Currently among TCSA's projects include the \$13 billion Boston Central Artery/Tunnel Project which is the largest, most complex and technologically challenging construction project in American history.

Prior to TCSA, Mr. Chevrier held key management positions in Stone and Webster Engineering Corp. and General Dynamics. At Stone and Webster, he built and managed their corporate Information Engineering Group and then pioneered their movement to client/server construction management solutions for the utility industry. Later as Division Manager of Advanced Database Developments, Chevrier created and led over a dozen teams on many high profile operations including several nuclear power plants and in the 80's he and his team designed, developed and implemented the first known relational database driven construction project management system in the nuclear construction market which was implemented on the VAX-Oracle platform and then the PC platform.
